HSNC reserves the right to immediately remove the graphics and the link from its web site if the image or content of sponsor web site are objectionable. No refunds of sponsoring fees will be made in such cases.
- 2. Advertisement Fee .** The Sponsor will pay HSNC advertising fee per selection above for duration of 12 months. Such amount shall be due with this form. HSNC may change the advertising fees from time to time, although no such change may be retroactive. If a message is placed during middle of year the fee will be prorated based on prorated monthly charge.
